- IATA requires that all animals must be able to sit, stand, lie down without curling in front feet, turn around and have 3 inches above the head when standing. PAC reserves the right to modify carriers that do not meet these standards. The credit card above will be charged for additional costs related to required modifications.
- Any incidents beyond our control which delay your animal's flight schedule (such as weather, flight delays/cancellations, issues with health documents, strikes, etc) will likely incur additional costs. The credit card above will be charged for any additional services needed as a result.
- Your estimate was provided based on airline & other provider fees in effect at the time it was given. These do not typically fluctuate significantly. If any changes are over and above the not to exceed amount indicated above, we will notify you and request additional authorization.
- Unless specifically stated in your estimate, customs clearance fees are not included and are the receivers responsibility to pay upon retrieval of the pet(s).
- In special circumstances we may be able to accommodate a shipment with less than 7 days notification. In this case, shipper will incur a rush charge \$75 for domestic & \$150 for international
